Ada County is auctioning a 2008 Ford Crown Victoria Police Interceptor Sedan 4-DR, 4.6L V8 SOHC 16V, white/black in color. The glass is chip free and has no cracks. The vehicle has automatic transmission, power steering, power windows and power door locks. The body of the vehicle does have scratches as portrayed in the pictures. The county decals have been removed, but impressions remain. The paint on the roof is peeling with some rusted areas, also some peeling on the right back panel next to the window. There are holes in the front bumper where the push bar was removed. The top of the vehicle has some patched areas where the light-bar was removed. The interior cloth front seat is fraying on the driver's side. The back seating is a prisoner transport system. The dash and floor are in good condition. There are scratches around the ignition area. The vehicle will not meet CARB (California Air Resources Board) emissions. The Crown Victoria does have a spotlight, but it is dim. The vehicle runs nicely and the engine is quiet. The check engine light is on, the diagnostic code is P0451. The overall condition is fair.

The vehicle is being sold "as is, where is". Bidders are encouraged to view the vehicle prior to bidding. The winning bidder is responsible for removal of the vehicle ten (10) business days after notification of award of the winning bid.
