1. Would there be a point of contact for each location?

Answer: There will not always be a point of contact person for each location due to some locations being at schools and they do not provide a contact person.

2. In the case we don't have somebody to contact, how do we know where to take the items?

Answer: At the schools, they would be delivered to the front office.

3. Are school officials willing to sign?

Answer: No

4. Are bidders to bid on the basis of worst case scenario?

Answer: Review the bid form. Also, bidders are asked to specifically bid seventy pallets.

5. If you win the first bid, you get the second bid automatically?

Answer: The contract will be awarded based solely on the bid for transportation of Equipment for all 144 precincts. See Instructions to Bidders, item #15.

6. Which bid is optional?

Answer: All are required, except for the early voting option.

7. The printers don't necessarily have specific precincts?

Answer: No, just one per precinct.

8. Do you mind if we come a day or so before to reorganize it?

Answer: It's approximately one week to one week and one day prior.

9. Are we responsible for set-up and break down of all equipment? We would expect signs to be back in the building instead of us picking them up?

Answer: No, only drop-off and pick-up of equipment. Signs will be picked up by another party.

10. This bid is happening because of having new equipment, so are there specific requirements on where it is to be stored, how it is to be stored, etc.?

Answer: Yes, due to calibration of printers. Handle equipment gently.

11. What about temperature issues related to storage?

Answer: Keep all the equipment above freezing (32 degrees Fahrenheit) at all times and do not expose any equipment to the outside elements other than the absolute minimum exposure required for loading and unloading.

12. Can we bring pallets in on trucks to off load the equipment?

Answer: Yes, there is a loading dock at the back of the warehouse with a roll up door that can accommodate pallets.
